FEE POLICY STATEMENT PLEASE READ AND UNDERSTAND THE FOLLOWING.

The Fee Policy Form pertains to the supporter fees associated with accessing the benefits of Unitary America, Inc. (hereinafter referred to as Unitary America) paid by the user of these services (hereinafter referred to as “you”) and any other sub-organizations or an organization where Unitary America is the parent, controlling entity. Funding for Unitary America and its organizations consist almost exclusively of donations and membership fees/ dues. The fees go towards expanding capacity, providing more benefits, advertising, website upkeep, costs associated with employment, and any other relevant costs that Unitary America may need to fulfill its tax-exempt purposes. Through this supporter fee, you can access any benefits without restriction. By becoming a supporter of Unitary America, you are automatically entitled to participate in all other programs and initiatives. The annual charge for membership is \$60, excluding that of 2026, which is established as \$55. This fee will be collected through any of the applicable means: payment via a check sent to the main business address of Unitary America, payment via an online portal provided by DonorBox, or payment via cash or check during a meeting or other event held by the organization.

You hereby agree to abide by and be subject to the Privacy Policy of Unitary America, and or any other third-party processing parties, including your personally-identifiable information. You also hereby agree to provide your Member Number when paying your supporter dues. Unitary America will not verify income status.

SUPPORTER AGREEMENT

PLEASE READ AND AFFIRM THE FOLLOWING

Section 1

1.1 This Supporter Agreement, hereinafter referred to as "The Agreement" is between the prospective and or current supporter, hereinafter referred to as "I" and Unitary America, Inc., hereinafter referred to as "Unitary America."

1.2 I hereby confirm, validate, and agree that all information submitted herein is verifiable and true. All information provided is exact, and no false or misleading information was provided maliciously, and or with the intent of misleading Unitary America.

1.3 I hereby understand that the registration of my support and the granting of my supporter status is tentative, and is not, in any way, shape, or form, guaranteed by Unitary America. I agree to not hold Unitary America or its subsidiaries, or any of its employees, affiliates, directors,

volunteers, officers, agents, and other associated individuals responsible, wholly or in part, for this decision.

1.4 I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless Unitary America, to the fullest extent of the law, its employees, affiliates, directors, volunteers, officers, agents, other representatives, and associated individuals against any and all damages, liabilities, expenses and/or loss, including court costs and attorney's fees resulting from any claims, suits, proceedings, causes of action brought by a third party against Unitary America or any of its employees, affiliates, directors, officers, agents, and other representatives and other associated individuals which may arise from or in connection with my participation in, support for, employment in, relating to, and or associated with, Unitary America or its programs.

1.5 I hereby agree, verify, certify, and defend that I have been bound to all clauses, subclauses, and terms and conditions present in this agreement herein, to the fullest extent permitted by all available laws, rules, and regulations.

1.6 I also hereby understand that if I do not agree to be bound by (or cannot comply with) any of the terms, clauses, subclauses, conditions, regulations, requirements, laws, or any other applicable content herein, then I will not submit any forms for approval or verification by Unitary America and will not attempt to continue further with my involvement in the organization.

Section 2

2.1 I agree that by giving my personal information, it will be used for the purposes outlined herein. Unitary America collects personally identifiable information that is voluntarily provided to the organization, or any other third-party organization affiliated or otherwise trusted by Unitary America with collecting, maintaining, or in which those third-party services are essential to the organization fulfilling its tax-exempt purposes.

2.2 I hereby agree that this personal information shall be used for purposes to fulfill the tax-exempt purposes of Unitary America, operate its programs, deliver services, operate the organization, and otherwise any purpose that Unitary America deems as relevant that is not restricted or regulated by any applicable state or federal statute, law, or regulation.

2.3 I understand that Unitary America shall not, under any circumstances, sell my personal information to any other third-party entity.

2.4 I understand that Unitary America may share my personally identifiable information, in aggregated or actual form, with third-party entities for any of Unitary America's valid purposes outlined in Section 2.2. These functions may include, although are not limited to, processing registered supporters, event planning, sending communications, processing fees, collecting donations, and operating its programs.

2.5 I hereby agree that Unitary America will share my personally identifiable information when required to do so by law, or in the good faith belief that such action is

necessary to comply with state or federal laws, or to respond to a court order, subpoena, or search warrant.

2.6 I hereby agree that Unitary America may share my personally identifiable information if it believes it is necessary to protect the safety of the organization, its supporters, its volunteers, or its programs.

2.7 I hereby agree that Unitary America may share my personally identifiable information regarding you with third parties in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of its business to another company.

2.8 I affirm and understand that Unitary America will keep my information on a confidential basis and will ensure that my information is stored appropriately. Unitary America implements reasonable administrative and technical measures to ensure that personal data is not compromised, and or exposed via unauthorized users. In the event of an unavoidable security incident, Unitary America is required to notify all supporters that have, or any person who has, personal information stored with, or maintained by the organization, within a twenty-four (24) hour window. However, if my personal information detailed herein is subject to unauthorized access, distribution, and or dissemination, provided that Unitary America has maintained reasonable security practices outlined in this statement, I agree and certify that Unitary America, and its affiliates, board of directors, employees, or volunteers shall not be held liable for any damages, direct or indirect, caused by such an event.

2.10 I hereby agree that if I do not agree to the data storage, usage, and processing requirements found either herein, I will not submit, sign, or otherwise complete the Supporter Registration Form. If I have already done so, I will not further engage or participate within the organization. By submitting this form, and by either signing this form or digitally affirming acceptance of the Supporter Agreement, I am bound to the terms and conditions present herein regarding my privacy in their entirety.

2.11 I hereby agree that Unitary America will only provide automated text messages to those that have opted-in to receive said messages. Providing a mobile number via the Supporter Registration Form, or any other form distributed by the organization, does not automatically enroll a supporter in text messaging notifications about any express purpose. For certain registration methods, I understand that I must respond with YES when prompted to receive text message notifications and or be contacted via my mobile number. These mobile alerts are utilized for contacting me about my membership status, upcoming events, volunteer opportunities, and other campaigns held by Unitary America. I reserve the right, at any time, to respond STOP to any text message sent by Unitary America, in which I will no longer receive said text message notifications. 2.12 I hereby understand that if I reside in California and I have provided Unitary America with personally identifiable information, I may request information once per calendar year about Unitary America's disclosures of

certain categories of my personally identifiable information to third parties. Please address these requests to:

2.13 I hereby understand and affirm that Unitary America may update this Privacy Policy at its sole discretion, effective immediately. However, I will receive a notification when this Privacy Policy has been changed or otherwise altered for any purpose, unless I have opted-out of text messaging and or email communications within twenty-four (24) hours. If I continue to use the services, programs, engage with, or interact with Unitary America will be considered further acceptance of this revised Privacy Policy. I acknowledge, agree, and attest that it is my sole responsibility to review this Privacy Policy herein periodically and become aware of any changes that may occur.

2.14 I hereby understand that I may delete my personal information by addressing these requests to privacy@unitaryamerica.org. Unitary America, in fulfilling this request, has the authority to retain certain aspects of my personally identifiable information to comply with relevant local, state, and federal laws, and or to ensure further compliance of any regulations regarding the organization.

Section 3

3.1 I hereby have read the statements given herein in the Fee Policy Statement regarding the payment of supporter fees, dues, and any other costs arising from my involvement in Unitary America.

3.2 I confirm, attest, and agree that if I fail to pay the required supporter fees, dues, or any other applicable costs, that I may be suspended from the organization at the end of said calendar year, at the sole discretion of Unitary America.

3.3 I hereby agree to pay the membership fee of sixty dollars (\$60 per year). I hereby understand that there may be exceptions to this rule solely determined by Unitary America. Recurring payments of this fee, if authorized by myself, shall be permitted, and will be charged in January of the applicable year. I have the right to cancel these recurring payments at any time with no threat to my status within the organization, or access to the organization's programs, benefits, or other initiatives that the organization may choose to operate. I understand and affirm that Unitary America may not charge me more for my status in the organization than the cost publicly stated herein in Section 3.3, and within the Fee Policy Statement.

3.4 I hereby understand that this fee payment entitles me towards all programs, initiatives, and other benefits provided through either Unitary America. I hereby confirm and understand that these benefits are supplied by said entities at their own discretion – these benefits may be removed or modified at the sole discretion of Unitary America. I understand that Unitary America is required to notify me when any of these benefits change, are removed, and or are added within thirty (30) days of the change. I reserve the right to cancel the renewal of my supporter fee due to any program changes.

3.5 I hereby understand that if I voluntarily choose to waive my supporter fee, I understand that the fee waiver is granted at the sole discretion of Unitary America, and I am

in no way guaranteed to be granted the fee waiver. I understand that fees shall be collected either at meetings or events held officially by Unitary America, through checks addressed to Unitary America's primary business address as indicated on its Articles of Incorporation, and or through an online payment portal provided and operated by DonorBox.

3.6 I hereby understand that if a third-party entity has been entrusted by Unitary America with the collection of my supporter fees and the personally identifiable information connected with said fees, then I hereby agree to the processing of my information for these purposes. I hereby agree to the Privacy Policies of any of these third-party entities, and I have had the opportunity to view, understand, and affirm these Privacy Policies. 3.7 I hereby understand that Unitary America takes no responsibility for the privacy practices employed by any other third-party entity, or the data storage and processing practices related thereto. I hereby affirm Sections 2.1-2.13 regarding the processing of my personally identifiable information and therefore of my financial details by third-party entities and by Unitary America, if the latter is applicable.

3.8 I hereby understand that I have, upon my first annual payment and all subsequent payments thereafter, that I have had the opportunity to waive my supporter fee. I hereby attest to the function of this form and hereby declare that I have been properly alerted to the existence

and function of the fee waiver mentioned. By not declaring that I would like to waive my supporter fee, I hereby consent to the payments I have made to Unitary America, or any other affiliated organization or entity.

3.9 I hereby agree that if my status within the organization is rescinded, canceled, or otherwise declared null and void by Unitary America, then I may not request a refund of the supporter fee, in any form. If Unitary America revokes my supporter status without an explicit, written cause communicated to me, I understand that organization will provide a refund for the remainder of the calendar year (\$5 per month).

3.10 I hereby understand, agree to, and defend that the supporter fee is not tax-deductible under IRS Code 501(c)(4).

Section 4

4.1 I also agree that I will not engage, support, fund, deceive, or otherwise seek to bring damage against Unitary America and any sub-organizations, affiliates, its supporters, its employees, its directors, and any other entity related directly or indirectly to Unitary America to the maximum extent afforded by any applicable laws, statutes, and regulations.

4.2 I will be held entirely responsible and liable for any and all damages brought forth against these parties in Section 4.1 to the fullest extent permitted by law. I also hereby declare that I do not support, fund, or otherwise am a member of any organization that seeks to damage Unitary America, its affiliated organizations, and its partners. If I am, then my status in the organization shall be rescinded

immediately. I also agree, in the case of criminal prosecution, that I may be responsible for any related fees due to the criminal proceedings against me.

4.3 I also confirm and validate that I am eighteen years or older. If I am under eighteen years of age, my parent or legal guardian is legally required to sign a Parental Consent Notification Form to allow my membership within the organization. Only upon completion of this Parental Consent Notification will my application be considered for approval.

4.4 I hereby agree that I am bound to all clauses, subclauses, statements, and parts of the Agreement and the statements contained in the Agreement to the furthest possible extent. I hereby confirm, understand, attest, validate, agree, and attest that I have fully read and understood all the contents of the Agreement, and have understood the following information set forth by Unitary America.

4.5 I hereby affirm, defend, and attest to the fact that I have read and understand the full contents of the Agreement in their entirety.

4.6 I hereby confirm and understand that Unitary America may make changes to the Agreement at any time. These changes, should they occur, are effective immediately. I will be notified within one (1) week of these changes. Continued use, engagement, and interaction with Unitary America constitutes acceptance of these changes.
